REGULATION

The current trade environment reflects the rise of a form of protectionism. Besides tariff barriers, regulations are often used as an attempt to erect market entry barriers. Companies wishing to do business abroad have thus to comply with various regulations.

We support our clients in improving their access to markets in the EU and Turkey and help them comply with the regulatory requirements to which they are subject. EXPORT CONTROL & SANCTIONS

Exporting companies increasingly face exacting regulations of great complexity and could be subject to significant sanctions. We advise our clients on all export control regulations applicable to their trans-border transactions. Indeed, efficient international trade requires compliance with regulations ranging from nuclear dual-use goods, military goods, to chemicals. To that end, we support our clients' applications for export licences.

We establish and implement export control due diligence programs to enable our clients to run their business in conformity with these regulations. We also provide training programs to help our clients' employees prevent inconsistencies with the applicable export control rules.

Sanctions programs constitute another constraint that needs to be tackled in the course of cross-border transactions. We advise on the impact of economic sanctions that may be imposed by Turkish authorities against foreign individuals or entities.
